**CAMPING RULES & REGULATIONS:**

1. Camping spaces will be assigned by Fair Park Staff. Failure to abide by site assigned will result in forfeiture without refund.
2. A complete list of registered campers will be given to the Washington County Sheriff's Department.
3. A camping permit will be issued for the vehicle on this form and must be displayed in your vehicle dash/window. Unregistered vehicles will be towed from the area at owner's expense.
4. Each RV camping space is allowed to have one vehicle per camping space.
5. There will be special parking for tent campers.
6. No open flames or fire pits are allowed on the grounds.
7. Put garbage in appropriate receptacles. (Please help keep the grounds clean)
8. Quiet hours are 1:00am until 7:00am
9. No minors are allowed to stay overnight without adult supervision.
10. No refunds allowed for weather conditions.
11. Cancellations with less than 8 days notice prior to your arrival will be refunded 50% of your total camping fee.
12. Cancellations with more than 8 days notice prior to your arrival will be refunded less a \$20 processing fee.
13. **All pets must be on a leash at all times while outdoors and waste removed.**

I further agree that failure to abide by these rules/regulations will result in removal from the camping grounds without refund and banned from future camping.
